#### **ABOUT US**

This is a parent-led society school for Autistic, Cerebral Palsy, Multiple Disabilities and Mentally Retarded persons. The organisation runs a regular school plan under National Trust of Ministry of Social Justice and Empowerment, Government of India.

Persons with Disabilities undergo special education, dance and music therapy, sensory activities, occupational therapy, applied behavior analysis, physiotherapy and speech therapy by trained therapists, pathologists and educators. Distinguished board members including physicians, mentors and psychologists periodically assess the physiological, educational and psychological development of the persons with disabilities.

Apart from running a regular school for these differently abled children, this organization does its level best to provide support for social security, mental trauma and trivial family issues that are common to these ill-fated families.

### **Objectives of our organization:**

- For differently-able toddlers, children and youth, this organization do it's level best to support the social security, mental trauma, and trivial family issues that are common to these ill-fated families.
- The organization acts as a welfare family where parents of these persons with disabilities can find a mental shelter forever and grow awareness of the laws and human rights issues associated with their children.
- To support each individual to access and develop his/her educational, vocational, social and recreational opportunities to their fullest.
- To grow the awareness and understanding of our community and society to remove the social stigma.
- To integrate our beneficiaries into the mainstream of society

### We shall provide

- Special education to a poor beneficiary by a Bachelor in Special Education (Autism/MR),
- Forty five minutes session of occupational therapy to a poor beneficiary by Bachelor of Occupational Therapist,
- Free assessment to a below poverty line beneficiary,Psychological counselling session to a poor beneficiary by certified rehabilitation psychologist.
- Forty five minutes speech therapy to a poor beneficiary by Bachelor in Speech and Language Pathologist.
- Free Teaching and learning materials to Below Poverty Line beneficiary.



#### **Early Intervention unit:-**

Early intervention services at Kalyani Life Institute are targeted services to help young children below the age of 10 years with developmental delays or specific conditions like Autism Spectrum Disorder, Genetic Disorders, Birth Defects. Early intervention helps children to learn better and increases their chances for success in academics and overall life skills.

- **Physical skills** (reaching, crawling, walking, drawing, building)
- Cognitive skills (thinking, learning, solving problems)
- Communication skills (talking, listening, understanding others)
- Self-help or adaptive skills (eating, dressing)
- Social or emotional skills (playing, interacting with others)
- Sensory processing skills (handling textures, tastes, sounds, smells)

Different types of Therapies and services at Early Interventiion Units are

- Physical or occupational therapy
- Psychological Councelling
- Home visits
- Medical, Nursing or Nutrition services
- Social work services
- Transportation

A child who qualifies for an early intervention program may receive one or more of these services:-

#### Screening and assessment:-

Next step for the beneficiary's development starts after screening and assessment done by qualified and experienced Psychologist, Therapists and Special Educators.











#### Speech and language therapy:-

This is the continuation of the program of speech therapy thrice a week for four hours per day. Bachelor in Auditory and Speech Language Therapy from NIOH usually conducts this program @ six session per day. This program usually covers therapeutic activities for auditory improvement and oromuscular inputs, evaluation, diagnosis, treatment of communication disorders, cognitive disorders, voice disorders and swallowing disorders. This speech therapy program has high demand because of its visible impact and improvement of the beneficiaries. Our Speech therapy sessions help beneficiaries to overcome language impairment, communication difficulties, word finding and other semantic issues.

The main problems covered are:

- Articulation disorders: Difficulty producing sounds or syllables or saying words incorrectly.
- Fluency disorders: Including problems like stuttering, which is characterized by abnormal stoppages, repetitions, or prolonging sounds in words.
- **Dysphagia or feeding disorders:** Difficulties with eating and swallowing.
- Receptive or expressive communication disorders::-Difficulties understanding and processing language, or difficulty putting words together to form sentences, or trouble expressing or communicating in a socially acceptable way.
- **Complications from birth defects surgery:** Difficulty speaking due to effects of conditions like cleft palate or surgery involving the throat and mouth.





#### **Occupational Therapy:-**

The occupational therapy unit of KLI has it's measurable impacts, by Bachelor in Occupational Therapy from National Institute of Orthopaedically Handicapped.

Occupational therapy has its high need for the person with autism and associated sensory processing disorders. During these occupational therapy sessions, therapist usually cater the need of sensory inputs in the form of different occupational therapy protocol to improve visual, auditory, proprioceptive, tactile sensory integration, helps learning everyday tasks, improves motor skills, balance, and coordination, helps the PwIDs get better at doing basic tasks and improve their self-esteem, improves fine and gross motor skills and motor planning, helps with selfregulation and sensory processing. The processes used are Ball Bath, using scissors,------etc.

#### **Sensory Integration:-**

Sensory integration is carried out with consultation and strategies recommended by an occupational therapist, physiotherapist and/or speech-language therapist. The methods used by KLI are Ball Bath, sand bath different type of swing, other activities like jumping, rolling, hitting, pushing, Individual Education Plan (IEP) etc.

Beneficiaries who need sensory integration skills are mostly either over (hyper) or under (hypo) sensitive to input from the environment like visual, auditory, kinesthetic (touch), by taste and/or smell. They exhibit a range of behaviours to either block out over-stimulation or to get stimulation from a sense. These behaviours could include hitting/pinching of self, plugging ears, closing eyes, screaming, repetitive behaviours, rocking, over eating, difficulty transitioning from or to activities, inability to concentrate, distractibility, headaches, task avoidance, withdrawal, etc.

The methods used by KLI are Ball Bath, sand bath different type of swing, other activities like jumping, rolling, hitting, pushing etc.







#### Play and physical exercise:-

KLI's play and physical exercise unit, indoor and outdoor is very much effective for the neurobiological development to strengthen our beneficiaries' psychological health and motivate them with recreation and play. It improves their eye-hand coordination, body movement, imagination, pretending ability, building connections with another child or group of children and social interaction.

#### **Peer Group Education:-**



Peer Group education system is very beneficial our beneficiaries to improve with their friends which psychologically motivate their mind through organised learning, classroom management, building a relationship with discipline. Our group education classes has usually been organised by a senior caregiver under National trust with the guidance of Early Intervention Therapist.

Our beneficiariess learn a great deal and explain or express their ideas to others and participate in activities in which they can learn from their peers. They develop skills in organizing and planning learning activities, working collaboratively with others, giving and receiving feedback and evaluating their own learning.



#### Individual Education Programme:-

Our individual education plan depends upon four "R's, Responsibility, Respect, Resourcefulness and Responsiveness. Special educators plan these academic program with creative aptitude, socialization aspects and disciplinary procedures. This individualized learning encourages responsibility, emphasis on the development of curriculum, pro-academic and applied mode of teaching. The programs are designed to meet the individual PwIDs's exact needs. It is a written plan that spells out the specific types of help the child will get. Both the program and the plan are covered by special educators and needed therapists. The process begins with a full evaluation to know beneficiary's strengths and weaknesses, allows KLI to create a program of services and supports tailored to meet the individual's needs.

#### **Psychological Counselling:-**

Psychological counselling is specially given to the parents on regular basis has it's great outcome with subjective wellbeing and quality of life. Our clinical psychologist access the dysfunction and identify the extent of disability, true assessment on the important areas applying assessment tools and testing measures, interviews, review from past records, clinical observation, psychological examination. During this session psychologist measures certain specific kinds of cognitive function with measuring intelligence, memory, attention span, reasoning, visual perception.

Rehabilitation Psychologist helps the families to overcome trauma and helps them in integrating into the society.





#### **Behaviour Modification:-**

Behaviour modification sessions has been organised by psychologist who conduct in the form of applied behaviour analysis. This is very common for behaviour observation to better understand and measure some changes.

# **Vocational Activities**

#### **Vocational Unit**

Our Pre-Vocational and Vocational Units focus on the beneficiaries of daycare section who has attained 14 years of age to ensure the beneficiary's development in self-esteem, confidence and self-sufficiency in future. This unit has varieties in production, which are as follows:-

**Ball Pen Assembling:-** In this parts of ball pens are assembled by our children and marketed.

**Ground-nut Packaging** - In this unit, groundnut weighing 10 to 15 grams are packed for retail sale in railway compartments, other small vendors and local market.

**Rakhi Making -** Rakhi, is made seasonally and sold as friendship bands and Rakhis during the months of August and September, for Friendship Day and the Rakhi Festival. At Kalyani Life Institute's Rakhis are made by our beneficiaries under the expert supervision senior caregiver; to be sold directly by the organization, local market and recently they are sold online too.

**Showpiece making:-** Clay showpieces are made with plaster of paris dices and safe colours are used to colors them. Kalyani Life Institute follows the traditional handicraft methodology of Krishnanagar, Nadia, which is world famous for it's clay work. Beneficiaries usually make sculptures of Rabindranath Tagore, Netaji Subhas Chandra Bose, Iswar Chandra Vidyasagar, Mahatma Gandhi etc. The market of this showpiece has been targeted to the fair, organised by Kalyani Boi Utsav (Book Fair) or Satima Mela.





# **Vocational** Activities



#### **Vocational Unit**

Junk Jewellery Making:- Junk jewelleries like earrings, necklace, hair clip etc, with some trifle, useless ingredients (recycling) are made by our beneficiaries under the expert supervision of senior caregiver, and marketed in Kalyani Boi Utsav or Satima Mela, local market and Online.

**Diya Making:-** Diya production has a vital impact on the market, during the festival of Dipawali. The buyers of our organisation's Diya has improved manifold over the last two years. About 20000 units of production in this year has been targeted.

**Gardening:-** Gardeing unit has a good market in and around Kalyani as this city is known as Nursery City. Our Inca, Pompom flower tubs have been supplied to the nearby institutions as well as purchased by the individuals, this also brings the beneficiaries close to the nature.

**Spice Powder Making:-** Spice powder of some selected spices (No pepper) are grinded and refined to make spice powder, weighed and packaged to be marketed in the local market, under expert supervision.





#### **Vocational Unit (Future Projection)**

**Candle Making:-** This recently added unit produces candles in automated system are made by our beneficiaries under expert supervision, in quite a large amount to be sold in the Local market and online during Dipawali and all year round.

Incense Sticks Making:- This recently added unit produces Incense Sticks in automated system are made by our beneficiaries under expert supervision, in quite a large amount to be sold in the Local market and online all year round.



#### **AUDITORS REPORT**

The Members of KALYANI LIFE INSTITUTE

1. We have audited the attached Balance sheet of "KALYANI LIFE INSTITUTE" B-3/88 KALYANI, NADIA POST- KALYANI, DIST- NADIA, West Bengal, Pin-741235 as at 31.03.2019 & related Income & Expenditure Account on that date annexed thereto. These financial statements are the responsibility is to express an opinion on these financial statements based on our audit.

2. We conducted our audit in accordance with the auditing standards generally accepted in India. Those standards require that we plan and perform the audit to obtain reasonable assurance about where the financial statement are free of material misstatement. education, therapy and transport purpose.



Now Swastika is a regular student of Kalyani Life Institute Disha Section. KLI has covered her Niramaya Insurance and also applied for



Unique Disability Identity card(Swabalamban Card).

Swastika has been reimbursed with four Niramaya claims in last financial year with amounting Rs 9830.00.

She used to avail speech therapist in Saturday, used to attend one to one Individualised Education Plan every day with her grandmother in KLI and get fortnight intervention of Occupational Therapy and Behaviour



Management session and her Progress Monitoring Sheet (FACP) has achieved 80% under fifteen new goals.

She can now comb hair, wash own dress, wear kurti, make market list, read price tag, read fruits name, add single digit, write address(ph..no), tell time, dust own furniture, arrange school bag, tell small poem, greet card making, waiting for her term.
